**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 28 AUGUST, 2017**

At the annual general meeting (“AGM”) of HKC International Holdings Limited (the “Company”) held on 28 August, 2017, all the proposed resolutions as set out in the Notice of AGM dated 19 July, 2017 were voted on by poll.

As at the date of the AGM, the total number of issued shares of the Company was 996,265,022 shares, which was the total number of shares entitling the holders to attend and vote for or against all the resolutions at the AGM. No shareholders were required to abstain from voting on any of the resolutions proposed at the AGM.

The Company’s branch share registrar in Hong Kong, Pilare Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. The poll results were as follows:
