At the annual general meeting (“AGM”) of HKC International Holdings Limited (the “Company”) held on 22 August, 2016, all the proposed resolutions as set out in the Notice of AGM dated 20 July, 2016 were voted on by poll.

As at the date of the AGM, the total number of issued shares of the Company was 797,012,037 shares, which was the total number of shares entitling the holders to attend and vote for or against all the resolutions at the AGM. No shareholders were required to abstain from voting on any of the resolutions proposed at the AGM.
